Beyond a charming and comfortable family home though, the Ellen residence lately has a second purpose. It serves as Tim's base of operations for his business, Tim Ellen - New York Life. Tim maintained a commercial office for many years, but during Covid he, like many others, was forced to work from home. Most of his work was done by phone or zoom, but as time passed and the world began to get back to normal, he was faced with a choice. Ellen started toward his goal by working in the athletic department as well as a local radio station in Auburn, but soon realized that he was trying to break into a very closed field with quite a low turnover, and so opportunities are not common. As a young recently married man, he realized quickly that he needed to find a way to make money.

It was after working for his father's company and being promoted to a management position requiring a move to LaGrange that Tim was approached about working for New York Life. Ellen is a member and past board member of the Auburn Alumni Association and is proud to have recruited and led a small group of local alums in 2007, including



founders Ken and Marty Young, to resurrect the West Georgia Auburn Club (www.westgeorgiaauburnclub.com), a group that promotes Auburn University. Ellen also served as the first chair of the Charles D. Hudson Memorial Scholarship endowment. The scholarship is designed to help deserving Troup, Harris and Meriwether County students attend Auburn University. Under his leadership, the West Georgia Auburn Club became the first in the country to raise one million dollars for its scholarship endowment!

His love of Auburn football led to one of Tim's proudest accomplishments. He co-hosted the syndicated weekly radio show, "The Coach Pat Dye Show" alongside the great coach. Together they interviewed famous coaches and players from across the country and talked about the game that meant so much to both. The show began in 2013 and ran until COVID forced it into hiatus in March of 2020. Coach Dye's death in June of that year meant that the show was indeed over, but for those years, with the retired Hall of Fame coach, Tim got to live out his college dream of promoting college athletics to the public, and he has may memories of the friendship with Coach Dye that grew over the years.

Tim's community involvement is not limited to sports organizations though! He is a former board member of First Choice Women's Center, a Distinguished Past President of the LaGrange Kiwanis Club, and served on the Planned Giving Committee of the WellStar West Georgia Health foundation. He remains involved and actively supports these organizations.

Tim feels that he has had a dream career in a job that he never expected to have. A dream career because it has been successful, of course, in allowing him to work with people, develop relationships and serve his clients in critical areas of financial planning, but just as importantly, because it has allowed him the freedom to enjoy his most driving passion- his family. His face lights up and his broad smile beams when he shares that he was able to be at every dance recital, sports game and activity while his children were growing up. His frequent trips to New York allowed him to introduce his wife to the city, and all three of his children to other great destinations in his company travels. He was able to treat them to trips that were fun and educational, while still carving out time for his work.

During COVID, when the world slowed to a crawl, Ellen says that he was able to take stock and look back at all the things that bring joy into his life: his faith; his marriage; his children; his grandchildren; golf; his dog. Not one of those things, he realized, had anything at all to do with money.
